

2025 RGFPSL May Madness Tournament Rules 10U



The prevailing rules will be USA Softball playing rules with the exceptions noted below:

Time Limit – Pool and Bracket - game time is no new inning after 75 minutes or the completion of 7 innings, whichever comes first. Game time begins at the start of the first warm up pitch.

- The Umpire will notify the Scorekeeper of the start time.
- The Umpire will be the official timekeeper.
- Ties can occur in Pool Play. – See Tiebreaker Rule for Bracket Play
- If time has expired and the hometeam cannot catch up, the game will end.

Scorekeepers – Scorekeepers must sit close to the home plate umpire.

- The official Scorekeeper (home team) will log the official start time in the official scorebook.
- Scorekeepers will not cheer or coach during the game.
- Failure to provide a scorekeeper will result in a forfeit.

Home Team - Home team will be decided by a coin toss during the pre-game meeting.

Dugouts – The team in the top position on the bracket will take the 3rd base dugout. The team on the bottom position on the bracket will take the 1st base dugout. If a team has back-to-back games, they will occupy the same dugout for both.

Sportsmanship – Any player, coach, manager or spectator displaying unsportsmanlike behavior will subject themselves and/or their team to suspension from the game and/or forfeiting the game.

Lineup – All players present at game time must be in the batting lineup.

- The batting order remains the same throughout the game, even after defensive substitutions.

- If a player leaves the game, her position in the batting order will be skipped to the next batter with no penalty, however once she has missed an at bat, she may not reenter the game.
- There will be no penalty for a player who has been taken out due to injury.

Fielding Players – The 10U division will play with 9 players.

- A team can start a game with eight (8) players before forfeiting a game.
- A team may finish the game with eight (8) players.
- No guest players allowed.

Pitching – No pitcher may pitch more than 4 innings per game.

- If a tie occurs at the time limit of a game, or at the end of five innings, the current pitcher is allowed to continue pitching even if it exceeds her normal inning limit.
- During the Championship Game, there is no restriction on the number of innings a pitcher may pitch.

Substitutions – The 10U division will have open defensive substitutions, however, no player shall sit more than two innings per game. ThunderCats limitations are not in effect.

- The integrity of the batting order will be maintained throughout the game.

Base Running – Standard USA Base Running rules in effect (exception: see Stealing)

- Look Back Rule IS in effect.

Stealing – No Stealing restrictions

- Exception: See Dropped Third Strike

Courtesy Runner – At each coach's option, a courtesy runner may be used for the pitcher and catcher with two outs.

- The courtesy runner will be the last batter to make an out.
- If running for the pitcher and catcher in the same inning, then the second runner will be the out prior to the last out.

Infield Fly Rule – Rule in effect.

Dropped Third Strike – Rule in effect.

- Exception: The Batter-Runner may ONLY advance to 1st Base

Illegal Pitching – Rule in effect.

Run Rule – There will be a five-run limit per inning, per team.

Mercy Rule – Rule in effect; 15 runs after 3 innings, 12 runs after 4 innings, 8 runs after 5 innings.

Hit by Pitch – If a batter is hit by a pitch, she shall be awarded first base.

- A pitch that hits the ground before hitting the batter is still considered a hit by pitch.
- The batter must make an attempt to get out of the way of the pitch.

Taking the field - There will be one minute to switch from offense to defense between innings, at which time the Umpire will put the ball in play.

At the beginning of each inning, Pitchers will be allowed up to five warm up pitches, after which the Umpire will begin calling balls or strikes against the offending team (one minute or 5 warm-up pitches, whichever comes first).

Injured Player –

- a. When a player is not injured seriously, all efforts should be made to encourage her to continue to play. Once a player has left a game for an injury, she cannot re-enter the game.
- b. Under no circumstances may an injured player re-enter a game. If this happens, the PLAYER AND THE MANAGER WILL BE EJECTED FROM THE GAME.
- c. The umpire (not coach or manager) must declare the player as an injured player, and this must be noted as such in the official scorebook.
- d. If the injured player is a batter, the player who made the last out may assume the strike count, so the 'at bat' may be completed. If the injured player is a runner, the player who made the last out may take her place on the last base she reached safely.
- e. When the injured player who has left the game is scheduled to bat, her place in the batting order will be skipped to the next batter with no penalty.

Tie Breaker – Bracket Play Only: After time has expired (inning is completed or the end of 7 innings) and game is tied, the next inning starts with a runner on 2nd base (last batter from previous inning).

- If after the inning is completed and the game is still tied, the runner will start at 3rd base for all remaining innings until there is a winner.

Forfeit – If a team fails to start play within five minutes after the scheduled game start time, that team will forfeit the game.

Umpires – Every effort will be made to provide one adult umpire and one youth or adult umpire.

- All protests during Tournament Play will be resolved that evening of play by 3 impartial Executive Committee members, preferably the President, Umpire-In Chief and the Vice President.
- Any coach or manager wishing to protest a rule interpretation of a game MUST submit \$50.00 cash at the time of protest.
- If they win the protest, the manager will be refunded the \$50.00.
- If they lose the protest, the manager will forfeit the \$50.00. USA Rule 11 and the following will apply:
 - a. All protests must be conducted through the Umpire. The time and inning during which the protest occurred must be logged into the scorebook. The protest must be made prior to the umpire leaving the field of play.
 - b. Each team will present its case to the Executive Committee members separately, beginning with the team that filed the protest.
 - c. After all presentations are made, the Executive Committee will decide the issue with a closed door vote.
